**ORDINANCE NO. 2012-12**

**AN ORDINANCE OF THE BOROUGH OF CLARKS SUMMIT  
AMENDING ORDINANCE 82-4 OF JANUARY 6TH, 1982 AS CODIFIED  
IN THE CODE OF ORDINANCES BOROUGH OF CLARKS SUMMIT,  
CHAPTER 1, PART 5; AND ORDINANCE 2002-04. THE AMENDMENT  
WOULD REPEAL THE DEFINITION OF SURVIVOR'S BENEFITS TO  
REFLECT THOSE CHANGES ADOPTED BY THE STATE OF  
PENNSYLVANIA IN ACT 51 OF 2009.**

The Borough Council hereby ordains:

**Section 1.** Amendments to Borough Ordinance 82-4, dated January 6th, 1982; and Borough Ordinance 2002-04 which amended portions of Ordinance 82-4.

**Section 505. Benefits, Social Security Credit and Benefits.**

DELETE:

**Section 505.B (Ordinance 2002-04, dated October 2<sup>nd</sup> 2002)**

ADD:

**Section 505.B Survivor Benefits.**

3. Any regular full time police officer of the Borough of Clarks Summit who is retiring on or after January 1<sup>st</sup>, 1996, or has attained eligibility to retire, shall have survivor benefits calculated at Fifty Percent (50%) of the monthly pension or retirement benefits defined in Section 505. Survivor benefits are prescribed for the benefit (a) of surviving spouse and if no surviving spouse survives or if he/she subsequently dies, the (b) of the child or children under the age of eighteen years, of the regular full time police officer of the Borough of Clarks Summit retired on pension; except that is such child or children are attending college, then to and including age 23 years.

**Section 2. Repealer.** All ordinances or parts of ordinances, which are inconsistent herewith, are hereby repealed. The following ordinances or parts thereof are specifically repealed:

Ordinance 96-09 Section 503.3, dated July 2<sup>nd</sup> 1996

Ordinance 96-09 Section 505.B, dated July 2<sup>nd</sup> 1996

**Section 3. Effective Date.** This ordinance shall be effective ten (10) days after adoption by Borough Council.
