RESOLUTION OF THE BOROUGH OF CLARK'S SUMMIT AUTHORIZING THE BOARD OF COMMISSIONERS OF LACKAWANNA COUNTY TO SUBMIT AN APPLICATION FOR FEDERAL FISCAL YEAR 2019 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FUNDS IN THE AMOUNT OF \$101,502.00 ON BEHALF OF THE BOROUGH OF CLARK'S SUMMIT.
