**Sewer Report – AUGUST:** Jenn Basalyga is back and catching up. **Update on Trash conversion – hire part timer to handle billing** 

Bob Sheils made the first motion to increase Nicole Kelly to \$18.27 per hour, Sarah Lodwick would increase to \$17.91 an hour. Nicole Kelly will be made full time. Sarah's hours would increase as needed with the trash billing. Ms. Kehoe would like to begin the increase the following Monday as they being the work needed to set up the file. A letter would be sent out explaining the trash billing and a phone number for residents to call. Bob Sheils made the first motion to increase the hours for Nicole Kelly, by 20 hours a week and to make her a full time employee with benefits subject to the contract with the borough. Also, increase Sarah Lodwick's hours by 10 hours and increase her wage by \$2 an hour. This would be effective September 11, 2023, seconded by Frank Besten, vote was 6-0.

**Resolution 2023** – **Monroe County Share Grant:** David Jenkins made the first motion to approve Resolution 2023, this is for the grant for 2 police cars. The amount not to exceed \$140,000 for two vehicles, seconded by Bob Sheils, vote was 6-0.

**MMO:** Bob Shiels made the first motion to approve Gerrie Carey to sign the MMO, seconded by Davis Jenkins, vote was 6-0.

### 10. SOLICITORS REPORT

**Stormwater Regionalization – MOU:** Solicitor Hayes made suggestions for council as to changes the borough may want. There are 8 municipalities involved. We would have to wait for all to agree to a contract. The cost was unknown at this time.

**Anita Nealon – no left turn off Lansdowne:** Solicitor Hayes stated that she could move forward, with council's approval, to draft the ordinance which would state what is recommended, there is no left turn permittable from Lansdowne. Solicitor Hayes will draft that ordinance.

## 11. CORRESPONDENCE:

**Lackawanna County Recycling Office:** Ms. Kehoe stated that the borough will be participating in a tire recycling event on September 30<sup>th</sup>. There are volunteers needed. There is a fee to drop off a tire.

**Diane Kwolek – response from Donna McHale:** Street light in on Knapp Road, is being discussed.

**Susan Grady – traffic on State St:** Pedestrian safety on State Street discussed. Ms. Kehoe stated increase visibility, the state recommended fluorescent yellow stripes on

the sides of the crosswalks. The DPW will take care of that next spring. Also, make sure that cars are sufficiently far from the crosswalks. We would need to look at parking spaces that need to be eliminated. Solar lights are also an option.
